**Synopsis:**

On Friday January 28, 2022, at approximately 0200 hours, Members of the Talbot County Drug Task Force assisted by the Maryland State Police STATE Team, Queen Anne's County Drug Task Force, Dorchester County Drug Task Force, MSP Strategic Operation Group East, MSP K/9 patrol, Easton Police Department Patrol, Maryland State Police Easton Barrack Patrol, Maryland State Police Centreville Barrack Patrol executed a search and seizure warrant upon the person of Jonathan Wayne Hadrick, A/A/M, D.O.B 5/28/1959, his vehicle and his residence located at 31 Clay Street, APT 301, Easton, Maryland 21601.

Hadrick and his vehicle were stopped by the Maryland State Police Strategic Operation Group-East in the area of Rt.301 and John Brown Road in Centreville, Queen Anne's County, Maryland. Hadrick was the driver of the vehicle as Anashia Jamal Scott, A/A/F, D.O.B 12/5/1997 was the passenger. Members of the Talbot County Drug Task Force along with the Maryland State Police STATE Team and the Easton Police Department Patrol then responded to Hadrick's residence located at 31 Clay Street, APT 301, Easton MD 21601 to execute the search warrant on the residence. Entry was made into the residence without incident.

A thorough search of the vehicle as well as Hadrick and Scott and Hadrick's residence was conducted which revealed both to be in possession of thirteen (13) Vials containing 20.3 grams of suspected crack cocaine, eighteen (18) capsules containing 17.5 grams of suspected heroin and an amount of U.S Currency.

**Hadrick, who has a past criminal history of CDS related charges, Robbery, Assault and firearm related charges, was placed under arrest and charged with CDS: Possession with intent to distribute (heroin), CDS: Possession with intent to distribute (crack cocaine), CDS: Conspiracy Possession with intent to distribute (heroin), CDS: Conspiracy Possession with intent to distribute (Crack Cocaine), CDS: Possession not marijuana (heroin), CDS: Possession not marijuana (Crack Cocaine), and two (2) counts of CDS: Possession of Paraphernalia. Hadrick was held without bail.**

**Scott, who has a past criminal history of theft, disorderly conduct, and CDS related charges was placed under arrest and charged with CDS: Possession with intent to distribute (heroin), CDS: Possession with intent to distribute (crack cocaine), CDS: Conspiracy Possession with intent to distribute (heroin), CDS: Conspiracy Possession with intent to distribute (Crack Cocaine), CDS: Possession not marijuana (heroin), CDS: Possession not marijuana (Crack Cocaine), and two (2) counts of CDS: Possession of Paraphernalia. Scott was held without bail.**
