PRESS RELEASES

Warrant/CDS Arrest: On January 17, 2022, Deputies from the Talbot County Sheriff's Office arrested James Roy Geese, 56 of Denton, MD. Deputies performing a patrol check of Kingston Landing located Geese sleeping in his vehicle. Deputies developed probable cause to search the vehicle and located marijuana and paraphernalia. A records check revealed Geese had an outstanding warrant charging him with failing to pay a fine. Geese was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Geese was held pending further action by the court.

CDS Arrest: On January 18, 2022, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Village Street for a moving violation. Deputies developed probable cause to search the vehicle and located cocaine, heroin and paraphernalia in an amount indicative of possession with the intent to distribute. The driver was identified as John Wilson Tillery, 51 of Easton, MD and a passenger was identified as Jesse James Wilson, 68 of Easton, MD. Tillery and Wilson were arrested and charged with possession of a controlled substance with the intent to distribute and possession of a controlled substance. Tillery and Wilson were transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Tillery and Wilson were held pending further action by the court.

CDS Arrest: On January 23, 2022, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle for a registration violation on Tilghman Island Road near Foster Avenue. Deputies developed probable cause to search the vehicle and located cocaine and paraphernalia on the passenger, Ella Elizabeth Evans, 19 of Laurel DE. Evans was issued a criminal citation, charging her with possession of a controlled substance and paraphernalia. Evans was released from the scene upon her signature on the criminal citation.

Warrant Arrest: On January 21, 2022, Deputies from the Talbot County Sheriff's Office arrested Andy Julian Fuentes, 22 of Easton, MD. On January 13, 2022, the Talbot County District Court issued an arrest warrant charging Fuentes with violation of probation. Fuentes was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Fuentes was held pending further action by the court.

Warrant Arrest: On January 24, 2022, Deputies from the Talbot County Sheriff's Office arrested John Wilson Tillery, 51 of Easton, MD. The Circuit Court for Talbot County issued an arrest warrant charging Tillery with violation of probation on the original conviction of home invasion. Tillery was ordered held without bond at the Talbot County Detention Center pending further action by the Circuit Court.

Warrant Arrest: On January 24, 2022, Deputies from the Talbot County Sheriff's Office arrested Michael Perry Cooper, 35 of McDaniel, MD. Deputies responded to the 8000 block of New Road for an unwanted person at a residence, identified as Cooper. Deputies determined on December 10, 2021, the Circuit Court for Talbot County issued an arrest warrant charging Cooper with failing to appear for a scheduled court date on the original charge of possession of a controlled substance with the intent to distribute. Cooper was transported to the Talbot County Central Booking facility for processing and was ordered held without bond pending further action by the Circuit Court.

Illegal Possession of Firearms: On December 9, 2021, Deputies from the Talbot County Sheriff's Office responded to the 9000 block of Unionville Road for a report of a dispute involving a firearm. During the incident, Robert Harvey Bridge, 47 of Easton, MD was observed in possession of a shotgun. Deputies discovered Bridge was prohibited from possessing a firearm or ammunition by Maryland law. On January 21, 2022, a District Court Commissioner issued a criminal summons charging Bridge with illegal possession of a firearm and possession of ammunition. On January 25, 2022, deputies served Bridge with the criminal summons. Bridge was released upon his signature.

Warrant Arrest: On January 25, 2022, Deputies from the Talbot County Sheriff's Office arrested Santana Antonia Dennis, 37 of Chester MD. On December 17, 2021, the Talbot County Circuit Court issued an arrest warrant charging Dennis with failing to appear for a scheduled court date on the original charge of possession of a controlled substance. Dennis was transported to the Talbot County Central Booking facility for processing and was ordered held without bond pending further action by the Circuit Court.
