**Assault Arrest:** On February 6, 2022, Deputies from the Talbot County Sheriff's Office responded to the 5900 block of Manadier Road for an assault in progress. Deputies located two injured males at the residence, one suffering from a non-life threatening gunshot wound to the head. Investigation revealed Russell Patrick Sankovich, 49 and Ryan Patrick Sankovich, 21 both of Easton, MD were involved in a physical confrontation leading to the discharge of a firearm by Russell Sankovich. The parties are father and son. Both parties were transported to the University of Maryland Shore Medical Center for treatment. Russell Sankovich was treated and released, being placed under arrest and charged with assault with a handgun, assault, possession of a firearm when prohibited, use of a handgun in commission of a felony and reckless endangerment. Russel Sankovich was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Russell Sankovich was ordered held without bond.

**Warrant Arrest:** On February 6, 2022, Deputies from the Talbot County Sheriff's Office arrested Ariel Eduardo Salgado-Troshez, 26 of Easton, MD. On September 13, 2017, the Talbot County District Court issued an arrest warrant for Salgado-Troshez, charging him with assault. Salgado-Troshez was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Salgado-Troshez was ordered held pending additional action by the court.

**Warrant Arrest:** On February 7, 2022, Deputies from the Talbot County Sheriff's Office arrested Just'us Tyron Mills, 27 of Easton, MD. On January 28, 2022, the Talbot County District Court issued an arrest warrant charging Mills with violation of probation. Mills was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Mills was ordered held pending further action by the court.

Warrant Arrest: On February 7, 2022, Deputies from the Talbot County Sheriff's Office arrested Isaac Douglas Copper Jr, 41 of Easton, MD. On January 26, 2022, the Talbot County District Court issued an arrest warrant charging Copper with violation of probation. Copper was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Copper was ordered held pending further action by the court.

Warrant Arrest: On February 7, 2022, Deputies from the Talbot County Sheriff's Office arrested Lamont Charles Ross, 29 of Easton, MD. On November 22, 2021, the Dorchester County District Court issued an arrest warrant charging Ross with failing to appear for a scheduled court hearing. Ross was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Ross was ordered held pending further action by the court.
