PRESS RELEASES

Warrant Arrest: On February 22, 2022, Deputies from the Talbot County Sheriff's Office arrested Norman Randolph Copper, 47 of Delray Beach, FL. On January 13, 2022, the District Court of Talbot County issued an arrest warrant for Copper charging him with violation of probation on the original charge of driving while intoxicated. Copper was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Copper was ordered held pending further action by the court.

Warrant Arrest: On February 22, 2022, Deputies from the Talbot County Sheriff's Office arrested Leon Allan Raisin, 26 of Easton, MD. On February 22, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Raisin with failing to appear for traffic violations. Raisin was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Raisin was ordered held pending further action by the Circuit Court.

CDS Arrest: On February 23, 2022, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Black Walnut Point Road near Wharf Road for a moving violation. Deputies identified the occupants as Brandi Leigh Kehr, 34 of Denton, MD and Justin Keith Lowery, 37 of Tilghman, MD. Deputies developed probable cause to search the vehicle and located a controlled substance and paraphernalia. Kehr and Lowery were charged with possession of a controlled substance and paraphernalia on a criminal citation and were released on their signature.

Warrant Arrest: On February 23, 2022, Deputies from the Talbot County Sheriff's Office arrested Jose Leonel Sandoval-Rosario, 26 of Milford, Delaware. Deputies were investigating a report of a suspicious vehicle in the 8000 block of Quaker Neck Road, Bozman, MD when they encountered Sandoval-Rosario. A records check revealed two outstanding warrants issued by the District Court for Caroline County charging Sandoval-Rosario with failing to appear for scheduled court dates. Sandoval-Rosario was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Sandoval-Rosario was held pending further action by the court.

Warrant Arrest: On February 25, 2022, Deputies from the Talbot County Sheriff's Office arrested Christopher Lee Rockwell, 35 of Federalsburg, MD. On February 24, 2022, the District Court for Talbot County issued an arrest warrant charging Rockwell with malicious destruction of property. Rockwell was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Rockwell was ordered held pending further action by the court.

Warrant Arrest: On March 1, 2022, Deputies from the Talbot County Sheriff's Office arrested Wilbert Calvin Lamont Wilson Jr, 32 of Trappe, MD. On February 24, 2022, the Circuit Court for Talbot County issued arrest warrants charging Wilson with violation of probation on the original charge of possession of a controlled substance with the intent to distribute and fraud. Wilson was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Wilson was ordered held pending further action by the Circuit Court.

Warrant Arrest: On March 1, 2022, Deputies from the Talbot County Sheriff's Office arrested Elijah Cole Forrest, 25 of Denton, MD. On December 15, 2021, the Circuit Court for Talbot County issued an arrest warrant charging Forrest with failing to appear for a scheduled court hearing on the original charge of possession of a controlled substance with the intent to distribute. Forrest was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Forrest was ordered held pending further action by the Circuit Court.

Warrant Arrest: On March 3, 2022, Deputies from the Talbot County Sheriff's Office arrested Billy Everett Freeman, 29 of Camden, DE. On November 23, 2021, the Talbot County District Court issued an arrest warrant charging Freeman with possession of a controlled substance and paraphernalia. Freeman was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Freeman was released on a \$1,500 unsecured bond.
