PRESS RELEASES

CDS Arrest: On March 13, 2022, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Chapel Road near Honeysuckle Drive for an equipment violation. Deputies identified the driver as Justin Joel Trice, 33 of Easton, MD and with the assistance of TCSO K9 Raven, developed probable cause the search the vehicle. As a result of the search, Deputies located controlled substances and paraphernalia. Trice was placed under arrest and charged with possession of controlled substances and paraphernalia. Trice was released from the scene after receiving criminal citations.

Warrant Arrest: On March 14, 2022, Deputies from the Talbot County Sheriff's Office arrested Jacob Wayne Barklow, 24 of Tilghman, MD. On January 21, 2022, the District Court for Talbot County issued an arrest warrant charging Barklow with violation of probation on the original charge of driving while intoxicated. Barklow was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Barklow was held pending further action by the court.

Malicious Destruction of Property: On March 14, 2022, Deputies from the Talbot County Sheriff's Office responded to the intersection of Sinclair Avenue and Sunset Lane for a report of malicious destruction of property. Responding Deputies located two of the stop signs at the intersection had profanity written on them with a black marker. The stop signs are the property of Talbot County Maryland, with a replacement value of \$300.00. Warrant Arrest: On March 14, 2022, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Ocean Gateway near Queen Anne Highway for a registration violation. Deputies identified the driver as Mohamed Lamin Jabbie, 29 of Chino, CA. A records check revealed Jabbie had an active arrest warrant issued by the District Court for Anne Arundel County, charging Jabbie with failing to appear in court on March 8, 2021. Jabbie was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Jabbie was ordered held pending further action by the court.

Warrant Arrest: On March 15, 2022, Deputies from the Talbot County Sheriff's Office arrested Chance Alan Crissinger, 27 of St Michaels, MD. On September 30, 2021, the District Court for Talbot County issued an arrest warrant charging Crissinger with violation of probation on the original charge of driving while intoxicated. Crissinger was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Crissinger was held pending further action by the court.

Warrant Arrest: On March 17, 2022, Deputies from the Talbot County Sheriff's Office arrested Heather Carolyn Darby-Donavan, 51 of Easton, MD. On March 16, 2022, the District Court for Talbot County issued an arrest warrant charging Darby-Donavan with failing to appear for a scheduled court hearing on the charge of driving without a license. Darby-Donavan was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Darby-Donavan was held pending further action by the court.

Warrant Arrest: On March 17, 2022, Deputies from the Talbot County Sheriff's Office arrested Robert Samuel Trower, 54 of Trappe, MD. On March 15, 2022, the District Court for Talbot County issued an arrest warrant charging Trower with failing to appear when ordered by the court. Trower was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Trower was held pending further action by the court.

CDS Arrest: On March 17, 2022, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on St Michaels Road near Woodside Avenue for an equipment violation. Deputies identified the driver as Deric Wesley Cannon, 37 of Greenwood, DE and developed probable cause to search the vehicle. Cannon fled the scene in his vehicle prior to the search and was pursued on St Michaels Road. Cannon stopped his vehicle near Thanksgiving Lane and was placed into custody. A search of the vehicle revealed prescription medication not prescribed to Cannon. Cannon was charged with possession of a controlled substance, fleeing and eluding police as well as numerous traffic violations. Cannon was issued a criminal citation, traffic citations and released on his signature.
