PRESS RELEASES

MDOP Investigation: On March 26, 2022, Deputies from the Talbot County Sheriff's Office responded to the 29000 block of Woodridge Drive for a reported malicious destruction of personal property. The victim advised deputies, sometime during the night, unknown suspects entered their property and slashed the tires of their vehicle causing approximately \$300.00 in damages. CDS Arrest: On March 27, 2022, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Ocean Gateway near Talbot County Community Center for a moving violation. Deputies identified the driver as Jeron Albert Carter, 20 of Bryans Road, MD. Deputies developed probable cause to search the vehicle and located marijuana and prescription pills. Carter was charged with possession of a controlled substance and possession of marijuana. Carter was issued a criminal citation and a civil citation, being released on his signature.

Theft Investigation: On March 27, 2022, Deputies from the Talbot County Sheriff's Office responded to Neavitt Landing at 6151 Long Point Road for a report involving the theft of fuel filters from a boat. The victim reported a case of Racor fuel filters, valued at \$60 was stolen off his boat in the last week. Warrant Arrest: On March 28, 2022, Deputies from the Talbot County Sheriff's Office arrested Thomas A. Gallegos, 35 of Easton, MD. On November 17, 2020, the Talbot County District Court issued an arrest warrant charging Gallegos with failing to appear for a scheduled court hearing on the original charge of driving on a suspended license. Gallegos was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Gallegos was ordered held pending further action by the court.

Protective Order Arrest: On March 29, 2022 at approximately 4:33 pm, Deputies from the Talbot County Sheriff's Office served a temporary protective order on Curt William Lewis, 57 of Tilghman, MD. The protective order prohibited Lewis from entering the property or contacting the protected party. Less than one hour later, Deputies were notified Lewis had returned to the residence. Deputies located and arrested Lewis for violating the protective order. Lewis was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Lewis was held pending further action by the court.

Warrant Arrest: On March 30, 2022, Deputies from the Talbot County Sheriff's Office arrested Roland Clinton Wainwright, JR., 30 of Frederica, DE. An arrest warrant was issued by the Talbot County Circuit Court, charging Wainwright with failing to appear at a scheduled court hearing. Wainwright was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Wainwright was ordered held at the Talbot County Detention Center on a \$1,000.00 corporate bond.

Warrant Arrest: On March 31, 2022, Deputies from the Talbot County Sheriff's Office arrested Ariana Dorthea Jenkins, 29 of Easton, MD. The Dorchester County District Court issued an arrest warrant for Jenkins, charging her with violation of a peace order, which was issued on March 25, 2022. Jenkins was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Jenkins was held pending further action by the court.

CDS/Handgun Arrest: On March 31, 2022 at approximately 10:00 pm, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Ocean Gateway near Boh Brooks Road for a moving violation. Deputies identified the driver as Kevron LaMont Chase, 33 of Easton, MD and developed probable cause to search the vehicle. Deputies located marijuana, cocaine, \$2711.00 in US Currency and a loaded handgun. Chase was placed under and charged with possession of a controlled substance, possession of marijuana with the intent to distribute, firearm possession with felony conviction, transporting a handgun in a vehicle and possession of a handgun. Chase was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Chase was ordered held without bond.

Warrant Arrest: On March 31, 2022, Deputies from the Talbot County Sheriff's Office arrested Robert Samuel Trower, 54 of Trappe, MD. On March 23, 2022, the District Court for Talbot County issued an arrest warrant charging Trower with violation of probation for violating a protective order. Trower was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Trower was held pending further action by the court. Trower has been arrested by this office 18 times since March 2018.
