PRESS RELEASES

MDOP Arrest: On April 2, 2022, Deputies from the Talbot County Sheriff's Office responded to the 9000 block of Unionville Road for a malicious destruction of property. Deputies were advised by the victim that Anashia Samel Scott, 24 of Cambridge, MD, punctured two tires on his vehicle with a knife. The estimated value of the damaged tires is \$500.00. Scott remained at the scene and was issued a criminal citation, charging her with malicious destruction of property under \$1,000.00. Scott was released on her signature.

Warrant Arrest: On April 2, 2022, Deputies from the Talbot County Sheriff's Office arrested Jacob Charles Andrews, 30 of Wye Mills, MD. On December 8, 2021, the Circuit Court for Talbot County issued an arrest warrant charging Andrews with failing to appear for a scheduled court hearing on the original charge of assault. Andrews was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Andrews was held pending further action by the court.

CDS Arrest: On April 2, 2022 at approximately 11:30 pm, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on St Michael's Road near Oak Creek for a moving violation. Deputies identified the driver as Brandi Leigh Kehr, 35 of Denton, MD, and with the assistance of a TCSO K-9, developed probable cause to search the vehicle. Deputies located controlled substance paraphernalia, used syringes and smoking devices. Kehr was charged with possession of CDS paraphernalia on a criminal citation and released on her signature.

Warrant Arrest: On April 3, 2022, Deputies from the Talbot County Sheriff's Office arrested Jessica Abigail Miller, 20 of Trappe, MD. On March 25, 2022, the District Court for Anne Arundel County issued an arrest warrant charging Miller with failing to appear for a scheduled court hearing on the original charge of driving on a suspended license. Miller was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Miller was held pending further action by the court.

Warrant Arrest: On April 04, 2022, Deputies from the Talbot County Sheriff's Office arrested Todd Neil Holtzman, 55 of Easton, MD. On March 25, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Holtzman with violation of probation on the original charge of armed robbery. Holtzman was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Holtzman was held without bond pending a hearing with the Circuit Court Judge.
