## **PRESS RELEASES**

Warrant Arrest: On April 6, 2022, Deputies from the Talbot County Sheriff's Office arrested Jesse James Williams, 68 of Easton, MD. On April 4, 2022 the Circuit Court for Talbot County issued an arrest warrant charging Williams with failing to obey a condition of probation. Williams was transported to the Talbot County Central Booking facility for processing and was ordered held without bond pending further action by the Circuit Court Judge.

Handgun Arrest: On April 6, 2022, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Ocean Gateway near Kennedy Street for a moving violation. , Easton, MD. Deputies made contact with the driver and developed probable cause to search the vehicle, locating a loaded handgun in the possession of a passenger, Dejanay Quintara Monique Stith, 27 of Cambridge, MD. Stith attempted to discard the weapon and was placed under arrest. Stith originally provided a fictitious name to Deputies due to an outstanding arrest warrant from VA. Stith was charged with possession of a handgun on person, handgun in a vehicle and providing fraudulent personal information to avoid prosecution. Stith was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Stith was held pending further action by the court.

Warrant Arrest: On April 7, 2022, Deputies from the Talbot County Sheriff's Office arrested Troy Mantez Copper, 53 of Cordova, MD. On February 25, 2022, the Talbot County Circuit Court issued an arrest warrant for Copper charging him with failing to appear for a child support hearing. Copper was transported to the Talbot County Central Booking facility for processing and was ordered held pending further action by the Circuit Court Judge.

Warrant Arrest: On April 7, 2022, Deputies from the Talbot County Sheriff's Office arrested Amanda Leigh Pressley, 30 of Hurlock, MD. On January 24, 2022, the Talbot County Circuit Court issued an arrest warrant charging Pressley with failing to appear for a scheduled court hearing on the original charge of driving under the influence of drugs/alcohol. Pressley was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Pressley was held on a \$1,000.00 cash bond.

Disorderly Conduct Arrest: On April 17, 2022, Deputies from the Talbot County Sheriff's Office were called to the 29000 block of Greenfield Avenue for an intoxicated person. Deputies observed James Andrew Dotson, 29 of Trappe, Maryland yelling and disturbing the public peace. Dotson refused several orders to quiet down and enter his residence, becoming louder and directing his hostility towards police officers causing neighbors to exit their residences to observe his behavior. Dotson was placed under arrest and charged with failing to obey a reasonable and lawful order of a law enforcement officer and disorderly conduct. Dotson was transported to the Talbot County Sheriff's Office where he was charged and released on criminal citations, being released to a sober adult.

Warrant Arrest: On April 18, 2022, Deputies from the Talbot County Sheriff's Office arrested Dylan Thomas Bridge, 21 of Trappe, MD. On April 18, 2022, the District Court of Talbot County issued an arrest warrant charging Bridge with failing to appear for a scheduled court hearing on the original charge of driving under the influence of alcohol. Bridge was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Bridge was ordered held pending further action by the court.

Warrant Arrest: On April 18, 2022, Deputies from the Talbot County Sheriff's Office arrested Kasel Tyree Seth, 34 of Cambridge, MD. On April 6, 2022, the District Court for Talbot County issued an arrest warrant charging Seth with violation of probation on the original charged of malicious destruction of property. Seth was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Seth was held pending further action by the court.

Warrant Arrest: On April 22, 2022, Deputies from the Talbot County Sheriff's Office arrested Kenneth Stefan Bradley, 40 of Cambridge, MD. On April 19, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Bradley with violation of probation on the original charge of first degree assault. Bradley was transported to the Talbot County Central Booking facility for processing and was ordered held pending a hearing before the Circuit Court Judge.
