## **PRESS RELEASES**

Criminal Summons: On April 23, 2022, Deputies from the Talbot County Sheriff's Office served James Lee Duvall, 37 of Easton, MD with a criminal summons. The criminal summons charged Duvall with violating an active protective order. Duvall was released upon his signature and ordered to comply with the protective order.

Warrant Arrest: On April 23, 2022, Deputies from the Talbot County Sheriff's Office arrested Rodney Owen Horky, 62 of Pennsylvania. An arrest warrant was issued by the District Court for Baltimore City in 1997. The warrant charged Horky with theft, failure to perform services after being paid to do so. Horky was transported to the Talbot County Central Booking facility for processing and his initial appearance before a District Court Commissioner. Horky was held pending further action by the court.

CDS Arrest: On April 24, 2022, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Ocean Gateway near Old Trappe Road for a registration violation. Deputies identified the driver as Ian Federico Flores Cartagena, 23 of Laurel, MD and developed probable cause to search the vehicle. Deputies located marijuana and psilocybin mushrooms inside the vehicle. Cartagena was placed under arrest and charged with possession of a controlled substance and possession of marijuana. Cartagena was issued a criminal citation and a civil citation, being released upon his signature on the citations.

Protective Order Arrest: On April 25, 2022, Deputies from the Talbot County Sheriff's Office arrested Curt William Lewis, 57 of Tilghman Island, MD for violation of an active protective order. Lewis had been observed looking through the windows of the protected party and when confronted by Deputies, attempted to flee and resisted arrest. Lewis was highly intoxicated and taken into custody with minimal force. Lewis was charged with violation of a protective order, harassment, stalking and resisting arrest. Lewis was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Lewis was ordered held pending further action by the court.

Warrant Arrest: On April 26, 2022, Deputies from the Talbot County Sheriff's Office arrested Ronnie Lee McHenry, 30 of Berkeley Springs, WV. A District Court arrest warrant was issued for McHenry, charging him with failing to appear for a scheduled court hearing. McHenry was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. McHenry was held pending further action by the court.

Criminal Summons: On April 27, 2022, Deputies from the Talbot County Sheriff's Office served a criminal summons on Matthew Louis Kelley, 39 of Easton, MD. On April 21, 2022, the Talbot County District Court issued the criminal summons charging Kelley with possession of a controlled substance and possession of marijuana. Kelley was released upon his signature.

CDS Arrest: On April 28, 2022, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Ocean Gateway near Erickson Drive for a moving violation. Deputies identified the driver as Brandon Michael Howard Trice, 33 of Cordova, MD and developed probable cause to search the vehicle. Deputies located cocaine and heroin inside the vehicle. Trice was arrested and charged with possession of controlled substances and paraphernalia. Trice was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Trice was held pending further action by the court.
