# PRESS RELEASES

**Warrant Arrest:** On May 09, 2022, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Ocean Gateway near Hiners Lane for a moving violation. Deputies identified the driver as Terrez Adonis Hunter, 22 of Arlington, TX. A records check revealed Hunter was wanted through Tarrant County Sheriff's Office, Fort Worth, TX on an extraditable warrant. Deputies transported Hunter to the Talbot County Central Booking facility for processing and he was held on a fugitive warrant pending extradition to Texas.

**Warrant Arrest:** On May 12, 2022, Deputies from the Talbot County Sheriff's Office arrested Charles Adler III, 50 of Easton, MD. An arrest warrant was issued by the Talbot County District Court for second degree escape. Adler was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Adler was held pending further action by the court.

**Warrant Arrest:** On May 12, 2022, Deputies from the Talbot County Sheriff's Office arrested David Branhum Byrd, 20 of Easton, MD. An arrest warrant was issued by the Talbot County District Court for violation of a protective order. Byrd was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Byrd was ordered held pending further action by the court.

**Warrant Arrest:** On May 13, 2022, Deputies from the Talbot County Sheriff's Office arrested Matthew William Crosby, 38 of Easton, MD. On April 29, 2022, the District Court of Anne Arundel County issued an arrest warrant charging Crosby with failing to appear for a scheduled court hearing on the original charge relating to traffic offenses. Crosby was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Crosby was ordered held pending further action by the court.

Warrant Arrest: On May 13, 2022, Deputies from the Talbot County Sheriff's Office arrested Robin Carter Donald, 54 of Easton, MD. On May 2, 2022, the District Court for Anne Arundel County issued an arrest warrant charging Donald with failing to appear for a scheduled court hearing on the original charge of traffic offenses. Donald was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Donald was held pending further action by the court.

Warrant Arrest: On May 13, 2022, Deputies from the Talbot County Sheriff's Office arrested Terry Anthony Potter, 57 of Easton, MD. On March 4, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Potter with failing to appear for a scheduled court date on the original charge of theft scheme. Potter was transported to the Talbot County Central Booking facility for processing and was ordered held pending a hearing with the Circuit Court Judge.

Warrant Arrest: On May 15, 2022, Deputies from the Talbot County Sheriff's Office arrested Heather Darby Donavan, 51 of Oxford, MD. An arrest warrant was issued by the Talbot County District Court, charging Donavan with failing to appear at a scheduled court hearing on the original charge of assault. Donavan was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Donavan was held pending further action by the court.

UU/MV, Resisting Arrest: On May 16 2022 at approximately 8:30 pm, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Ocean Gateway near Dover Road for moving violations. Deputies identified the driver as John Francis Mulhare, 44 of no fixed address. Mulhare was operating a vehicle he was not authorized to be in possession of, was intoxicated, failed to identify himself to uniformed officers and resisted a lawful arrest. Deputies, with the assistance of Easton Police Officers, were able to detain Mulhare; however, he began to complain of injuries. Mulhare was transported to the University of Maryland Shore Medical Center at Easton where he was held for observation. Mulhare was charged with unauthorized use of a motor vehicle, theft, resisting arrest, hindering a police investigation and driving while intoxicated.
