## <u>Talbot County Drug Task Force</u> Press Release

Incident: Search Warrant/Arrest

## Synopsis:

On Thursday May 26, 2022 at approximately 1100 hours, members of the Talbot County Drug Task Force assisted by the Maryland State Police STATE Team, MSP Strategic Operation Group-East, MSP Gun Enforcement Unit-East, Easton Police Department Narcotics Unit, Talbot County Sheriff's Office CID, Talbot County Sheriff's Office Patrol, executed two search and seizure warrants located at 9415 Unionville Road, Easton, Maryland 21601 and upon the target of Deon Arnell Turner, A/A/M, D.O.B 2/24/1982 and Turner's vehicle.

A thorough search of 9415 Unionville Road, Turner and his vehicle was conducted which resulted in Turner being in possession of 80.2 grams of suspected Powder Cocaine, 73.4 grams of suspected crack cocaine, 44.1 grams of suspected heroin, Twenty Five (25) 10 mg Oxycodone Pills and Thirty Nine (39) 30 mg Oxycodone Pills (Total: 64), Nine (9) Sublingual Suboxone Strips, a large amount of U.S Currency as well as a .22 Cal Rifle.

Turner, who has a past criminal history of CDS related charges, Assault, False Imprisonment, and MDOP, was placed under arrest for CDS: Possession with Intent to Distribute (Crack Cocaine), CDS: Possession with Intent to Distribute (Powder Cocaine),

CDS: Possession with Intent to Distribute (Heroin), CDS: Possession with Intent to Distribute (Oxycodone), CDS: Possession Not Marijuana (Crack Cocaine), CDS: Possession Not Marijuana (Powder Cocaine), CDS: Possession Not Marijuana (Heroin), CDS: Possession Not Marijuana (Oxycodone), CDS: Possession Not Marijuana (Suboxone), Convicted Person in possession of a regulated firearm, and Possessing a firearm while committing a disqualifying crime. Turner was ultimately transported to the Talbot County Detention Center/Central Booking and is currently waiting to be seen by the District Court Commissioner.

The Talbot County Drug Task Force is a cooperative enforcement effort between the Maryland State Police, Talbot County Sheriff's Office, Easton Police Department, St. Michael's Police Department, Oxford Police Department, Maryland Natural Resources Police, and the Talbot County State's Attorney's Office.
