PRESS RELEASES

CDS Arrest: On May 27, 2022, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Elliott Road near Dover Road for a moving violation. Deputies identified the driver as Bryan James Hall, 30 of Federalsburg, MD and with the assistance of the Easton Police Department, developed probable cause to search the vehicle. Deputies located suspected heroin, crack cocaine, and prescription pills which were not prescribed to Hall in the vehicle. Hall was charged on criminal citations for possession of a controlled substance and released from the scene on his signature.

Warrant Arrest: On June 1, 2022 at approximately 1030 hours, Deputies from the Talbot County Sheriff's Office arrested Kevin August Smith, 31 of Easton, MD. On May 23, 2022, the District Court of Talbot County issued an arrest warrant charging Smith with violation of probation on the original charge of possession of a controlled substance. Smith was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Smith was held pending further action by the court.

Warrant Arrest: On June 10, 2022, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Ocean Gateway near Hiners Lane for a moving violation. Deputies identified the driver as Zachary Justin Peterson, 42 of Chincoteague, Virginia. A records check revealed Peterson had an open arrest warrant through Virginia. Peterson was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Peterson was charged as a fugitive from justice and held pending extradition to Virginia.

Warrant Arrest: On June 13, 2022, Deputies from the Talbot County Sheriff's Office arrested Antione Betrotious Crump, 22 of Washington, D.C. On June 3, 2022 the Circuit Court for Talbot County issued an arrest warrant charging Crump with failing to appear for a scheduled hearing. Crump was transported to the Talbot County Central Booking facility for processing and was ordered held without bond pending further action by the Circuit Court.

Warrant Arrest: On June 13, 2022, Deputies from the Talbot County Sheriff's Office arrested Tavon Pierre Bordley, 43 of Easton, MD. On June 2, 2022, the District Court for Talbot County issued an arrest warrant charging Bordley with possession with intent to distribute a controlled substance and possession of a controlled substance with the intent to distribute in a school zone. Bordley was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Bordley was held pending further action by the court.

Warrant Arrest: On June 17, 2022, Deputies from the Talbot County Sheriff's Office arrested Ashley Rochelle Potter, 38 of Easton, MD. On June 2, 2022, an arrest warrant was issued by the Talbot County District Court charging Potter with possession of a controlled substance. Potter was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Potter was held pending further action by the court.

Warrant Arrest: On June 17, 2022, Deputies from the Talbot County Sheriff's Office arrested Clifton Lavante Morton Sr., 46 of Easton, MD. On April 6, 2022, an arrest warrant was issued by the Talbot County Circuit Court charging Morton with failing to appear for his scheduled hearing involving child support. Morton was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Davis was ordered held at the Talbot County Detention Center without bond.

Domestic Violence Arrest: On June 18, 2022, Deputies from the Talbot County Sheriff's Office made contact with a victim of domestic assault at the Sheriff's Office. Investigation revealed the victim was assaulted by her husband, Norvin Hernandez-Velquez, 25 at their residence in the 31000 block of Skipton Cordova Road, Cordova, MD. The victim had visible signs of injuries consistent with domestic violence. Hernandez-Velquez was located and placed under arrest, charged with assault. Hernandez-Velquez was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Hernandez-Velquez was held pending further action by the court.

Warrant Arrest: On June 19, 2022, Deputies from the Talbot County Sheriff's Office arrested Robert Samuel Trower, 54 of Trappe, MD. On June 13, 2022, the District Court for Talbot County issued an arrest warrant charging Trower with failing to appear at a scheduled court hearing on the charge of trespassing. Trower was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Trower was held pending further action by the court. Trower has been arrested 13 times on warrants issued by the District and Circuit Courts for Talbot County since 2019 and has been involved in 37 incidents over that time with the Talbot County Sheriff's Office and Easton Police Department.

Warrant Arrest: On June 20 2022, Deputies from the Talbot County Sheriff's Office arrested Stephen Daniel Davis, 34 of Easton, MD. On June 8, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Davis with failing to appear for a scheduled hearing on the original charge of driving while intoxicated. Davis was transported to the Talbot County Central Booking facility for processing and was ordered held without bond.

Warrant Arrest: On June 21, 2022, Deputies from the Talbot County Sheriff's Office arrested Charles Melvin Ernest Potter, 55 of Easton, MD. On June 1, 2022, the District Court for Anne Arundel County issued two arrest warrants charging Potter with failing to appear for scheduled court hearings on traffic charges. Potter was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Potter was held pending further action by the court.

Warrant Arrest: On June 28, 2022, Deputies from the Talbot County Sheriff's Office arrested Jeremiah Whitmore Tolley, 26 of Seaford, DE. On May 31, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Tolley with failing to appear at a scheduled hearing on the original charge of indecent exposure. Tolley was transported to the Talbot County Central Booking facility for processing and was ordered held without bond pending further action by the Circuit Court Judge.

Assault Arrest: On July 2, 2022, Deputies from the Talbot County Sheriff's Office responded to the 24000 block of Deep Water Point Drive, St. Michaels, MD for a report of domestic assault. Investigation revealed a 34 year old female from Arlington, VA had been assaulted by her husband, Jacob Evans Hampton, 35 of Arlington, VA. Deputies noted injuries on the victim consistent with an assault and placed Hampton under arrest. Hampton was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Hampton was held pending further action by the court.
