# PRESS RELEASES

**Vehicle Pursuit/CDS Arrest:** On August 16, 2022, Deputies from the Talbot County Sheriff's Office attempted to stop a motor vehicle on Matthewstown Road near Colby Road for a moving violation. The vehicle failed to stop and continued to the 200 block of S. 6th Street in Denton, MD. Deputies, with the assistance of Caroline County Sheriff's Office, Denton Police Department, and the Maryland State Police apprehended the driver, Shaniya Nichole Frieson, 23 of Denton, MD. A search incident to arrest revealed controlled substances in the vehicle, and a records check revealed Frieson was driving on a suspended driver's license. Frieson was charged by citation with attempting to elude police, driving on a suspended license, exceeding the posted speed limit, possession of a controlled substance and possession of marijuana. Frieson was released at the scene after receiving citations.

**Assault Arrest:** On August 16, 2022, Deputies from the Talbot County Sheriff's Office responded to the 4000 block of N Main Street, Trappe, MD for a reported domestic assault. Investigation revealed Timothy Adams, 60 of Trappe, MD assaulted his wife, Dorothy Adams by choking and pushing her to the ground at their residence. Timothy Adams was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Timothy Adams was ordered held without bond.

**Warrant Arrest:** On August 24, 2022, Deputies from the Talbot County Sheriff's Office arrested Thomas Lee Bailey, 35 of Trappe, MD. On March 30, 2022, the Circuit Court for Talbot County issued arrest warrants charging Bailey with violation of probation and failing to appear for scheduled hearings on the original charge of armed robbery. Bailey was transported to the Talbot County Central Booking facility for processing and was ordered held at the Talbot County Detention Center pending further action by the Circuit Court.

Assault Arrest: On August 24, 2022, Deputies from the Talbot County Sheriff's Office arrested Sherry Lynn Lednum, 46 of Tilghman, MD. Deputies had responded to the 5000 block of Tilghman Island Road for an assault. Investigation determined Lednum had assaulted Christina Anne Marie Little over an argument involving money and an oyster permit. Lednum was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Lednum was ordered held without bond.

Warrant Arrest: On August 24, 2022, Deputies from the Talbot County Sheriff's Office arrested Andrew Joseph Emge, 33 of Hurlock, MD. On August 24, 2022, the District Court for Talbot County issued an arrest warrant charging Emge with possession with the intent to distribute child pornography and possession of child pornography. Emge was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Emge was ordered held pending further action by the court.
