PRESS RELEASES

Violation of Protective Order: On August 27, 2022, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Ocean Gateway near Bay Acres Road for a moving violation. The driver was identified as Charles William Farmer, 39 of Baltimore, MD and the passenger as Ashley Nicole James-Farmer, 37 of Baltimore, MD. A records check revealed Charles was the respondent of an active protective order, with Ashley as the protected person. Charles Farmer was placed under arrest and charged with violation of a protective order. Charles was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Charles was held pending further action by the court.

Criminal Summons Service: On August 27, 2022, Deputies from the Talbot County Sheriff's Office served a criminal summons on Christina Marie Little, 37 of Cambridge, MD charging her with trespassing. Little was released upon her signature on the criminal summons.

Warrant Arrest: On August 28, 2022, Deputies from the Talbot County Sheriff's Office arrested Tavon Pierre Bordley, 43 of Ridgely, MD. On August 19, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Bordley with failing to appear for a scheduled court hearing on the original charge of possession of a controlled substance with the intent to distribute. Bordley was transported to the Talbot County Central Booking facility for processing and was ordered held without bond pending for the action by the Circuit Court.

Warrant Arrest: On August 29, 2022, Deputies from the Talbot County Sheriff's Office arrested Clayton John Baynard, 31 of Federalsburg, MD. On April 6, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Baynard with failing to appear for a child support hearing. Baynard was transported to the Talbot County Central Booking facility for processing and was ordered held on a \$4,000.00 cash bond.

Criminal Summons Service: On August 29/2022, Deputies from the Talbot County Sheriff's Office served a criminal summons on James Lempke Jr, 55 of Trappe, MD. Lempke was charged with harassment and electronic communication harassment. Lempke was released from the scene upon his signature on the criminal summons.

Warrant Service: On September 1, 2022, Deputies from the Talbot County Sheriff's Office arrested Michael Edward Brummell, 41 of Easton, MD. Deputies responded to the George W Hill Corrections Facility and extradited Brummell back to Maryland. On March 3, 2020, the Circuit Court for Talbot County issued an arrest warrant charging Brummell with failing to appear for a scheduled court hearing and violation of probation on the original charges of distribution of a controlled substance and escape. Brummell was transported to the Talbot County Central Booking facility for processing and was ordered held without bond pending further action by the Circuit Court.

Violation of Protective Order: On September 1, 2022, Deputies from the Talbot County Sheriff's Office responded to the 7000 block of Quaker Neck Road, Bozman, MD for a reported violation of a protective order. Harold Ira Talkington 3rd, 70 of Bozman, MD contacted the protected person via telephone, violating the final protective order for the second time, and violating pretrial release conditions. Talkington was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Talkington was ordered held without bond pending further action by the courts.
