PRESS RELEASES

Warrant Arrest: On September 3, 2022, Deputies from the Talbot County Sheriff's Office arrested Walter Kenneth O'Dowd Jr, 34 of Easton, MD. On September 14, 2021, the District Court of Talbot County issued an arrest warrant for O'Dowd, charging him with failing to appear for a scheduled hearing on traffic charges. O'Dowd was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. O'Dowd was held pending further action by the court.

Warrant Arrest: On September 3, 2022, Deputies from the Talbot County Sheriff's Office arrested Traviar Damonte Davis, 46 of Denton, MD. On April 11, 2022, the Talbot County Circuit Court issued an arrest warrant for Davis, charging him with failing to appear for a scheduled hearing on the charge of driving while intoxicated. Davis was transported to the Talbot County Central Booking facility for processing and was ordered held without bond pending further action by the Circuit Court Judge.

Warrant Arrest: On September 4, 2022, Deputies from the Talbot County Sheriff's Office arrested Tabitha L Clark, 22 of Rock Hall, MD. On October 8, 2021, the Kent County District Court issued an arrest warrant charging Clark with failing to appear for a scheduled court hearing. Clark was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Clark was held pending further action by the court.

Warrant Arrest: On September 8, 2022, Deputies from the Talbot County Sheriff's Office arrested Harold Ira Talkington, 70 of Bozman, MD. On September 8, 2022, the Talbot County District Court issued an arrest warrant charging Talkington with failing to comply with pretrial release conditions and a revocation of his previously posted bond. Talkington was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Talking was ordered held without bond.

Warrant Arrest: On September 08, 2022, Deputies from the Talbot County Sheriff's Office arrested Just'us Kamara Tyron Mills, 28 of Easton, MD. On September 2, 2022, the Talbot County District Court issued an arrest warrant for Mills, charging him with violation of probation on the original conviction of assault. Since 2004, Mills has been involved in fifty-three (53) incidents involving police action and has been arrested fifteen (15) times since 2014. Mills was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Mills was held pending further action by the court.

Warrant Arrest: On September 9, 2022, Deputies from the Talbot County Sheriff's Office arrested Paul William Bresch, 30 of Denton, MD. On July 11, 2022, the Talbot County Circuit Court issued an arrest warrant charging Bresch with violation of probation on traffic charges. Bresch was transported to the Talbot County Central Booking facility for processing and was ordered held without bond pending further action by the Circuit Court Judge.

Warrant Arrest: On September 9, 2022, Deputies from the Talbot County Sheriff's Office arrested Carrie Lynn Eason, 37 of Cordova, MD. On October 11, 2019, the Talbot County Circuit Court issued an arrest warrant charging Eason with failure to appear for a scheduled hearing on the original charge of possession of a controlled substance. Eason was transported to the Talbot County Central Booking facility for processing and was ordered held without bond pending further action by the Circuit Court Judge.
