## **PRESS RELEASES**

Violation of Protective Order/ CDS Arrest: On November 11, 2022, Deputies from the Talbot County Sheriff's Office responded to the 4200 block of Koogler Road, Trappe, MD in reference to a violation of a protective order. Deputies learned that William Daniel Sard, 40 of Trappe, MD, violated a final protective order by contacting the protected person via Snapchat. Sard was placed under arrest, and during a search of his person, a controlled substance was located. Sard was charged with violating a final protective order and possession of a controlled substance. Sard was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Sard was held pending further action by the court.

Warrant Arrest: On November 21, 2022, Deputies from the Talbot County Sheriff's Office arrested Adrian Kmar Waters, 34 of Denton, MD. On January 13, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Waters with violation of probation on the original charge of assault and burglary. Waters was transported to the Talbot County Central Booking facility for processing and was ordered held pending further action by the Circuit Court.

Warrant Arrest: On November 22, 2022, Deputies from the Talbot County Sheriff's Office arrested Jairo Ricardo Perdomo-Cantarero, 28 of Queen Anne's County, MD. The Circuit Court for Queen Anne's County issued an arrest warrant charging Perdomo-Cantarero with violation of probation. Perdomo-Cantarero was turned over to the custody of the Maryland State Police - Centerville.

Warrant Arrest: On November 23, 2022, Deputies from the Talbot County Sheriff's Office arrested Dione Frank Tate, 40 of Salisbury, MD. On October 5, 2022, the District Court for Talbot County issued an arrest warrant charging Tate with failing to appear for a scheduled court hearing on the original charge of driving an uninsured vehicle. Tate was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Tate was held pending further action by the courts. Warrant Arrest: On November 23, 2022, Deputies from the Talbot County Sheriff's Office arrested Kenneth William Vollmerhausen, 38 of ST Michaels, MD. On November 22, 2022, the District Court for Talbot County issued an arrest warrant charging Vollmerhausen with burglary and theft. Vollmerhausen was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Vollmerhausen was ordered held at the Talbot County Detention Center without bond.

Warrant Arrest: On November 23, 2022, Deputies from the Talbot County Sheriff's Office arrested John Paul Kilpatrick, 39 of Baltimore, MD. On October 11, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Kilpatrick with failing to appear for a scheduled court hearing on the original charge of theft. Kilpatrick was transported to the Talbot County Central Booking facility for processing and was ordered held pending further action by the Circuit Court.

Warrant Arrest: On November 25, 2022, Deputies from the Talbot County Sheriff's Office arrested Charles Melvin Potter, 56 of Easton, MD. On November 4, 2022, the Anne Arundel County District Court issued an arrest warrant charging Potter with failing to appear for trial on the original charge of driving on a suspended license. Potter was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner, and was held on \$3,500 bond.

Warrant Arrest: On November 27, 2022, Deputies from the Talbot County Sheriff's Office arrested Cesar Anthony Torres-Ponce, 46 of Easton, MD. On February 6, 2017, the District Court for Talbot County issued an arrest warrant charging Torres-Ponce with failing to appear for a scheduled court hearing on the original charge of driving under the influence of alcohol. Torres-Ponce was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Torres-Ponce was held pending further action by the courts.

Warrant Arrest: On December 1, 2022, Deputies from the Talbot County Sheriff's Office arrested Pamela Nicole Miller, 35 of Easton, MD. On October 6, 2021, the Talbot County Circuit Court issued an arrest warrant charging Miller with failing to appear for a scheduled court hearing on the original charge of driving under the influence of alcohol. Miller was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Miller was ordered held at the Talbot County Detention Center pending a hearing. Warrant Arrest: On December 4, 2022, Deputies from the Talbot County Sheriff's Office arrested Johnny James Sneerinsen, 32 of Easton, MD. On May 27, 2022, the District Court for Baltimore City issued an arrest warrant charging Sneerinsen with failing to appear for a scheduled hearing or pay required fine. Sneerinsen was transported to the Talbot County Central Booking facility for processing and was ordered held on a \$150.00 bond.

Warrant Arrest: On December 5, 2022, Deputies from the Talbot County Sheriff's Office arrested Willie Edward Willis Jr., 28 of Baltimore, MD. Deputies traveled to RSW Regional Jail, Front Royal, Virginia after Willis waived extradition to return to Maryland. On September 9, 2022, the Talbot County Circuit Court issued an arrest warrant charging Willis with failing to appear for a scheduled court hearing on the original charge of driving without a license. Willis was transported to the Talbot County Central Booking facility for processing and was ordered held without bond pending further action by the Circuit Court.

CDS Arrest: On December 8, 2022, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Tilghman Island Road near Benders Lane for a registration and equipment violation. Deputies identified the driver as Brittany Kristen Cummings, 36 of Sherwood, MD. With the assistance of a Talbot County K9, Deputies developed probable cause to search the vehicle and located controlled substances. Cummings was charged on a criminal citation with possession of a controlled substance. Cummings was released from the scene upon her signature on the citation.
