## **PRESS RELEASES**

Warrant Arrest: On December 16, 2022, Deputies from the Talbot County Sheriff's Office arrested Otilio Ernesto Santizo-Lopez, 22 of Easton, MD. On November 30, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Santizo-Lopez with failing to appear for a scheduled court hearing on the original charge of driving while intoxicated. Santizo-Lopez was transported to the Talbot County Central Booking facility for processing and was ordered held pending a hearing with the Circuit Court Judge.

Warrant Arrest: On December 21, 2022, Deputies from the Talbot County Sheriff's Office arrested Jayquan Alfonso Bowens, 19 of Washington, DC. On July 23, 2021, the Circuit Court for Talbot County issued an arrest warrant charging Bowens with failing to appear for a scheduled court hearing on the original charges of possession of a controlled substance with the intent to distribute, possession of a controlled substance and possession of a firearm. Bowens was transported to the Talbot County Central Booking facility for processing and was ordered held pending further action by the Circuit Court.

Warrant Arrest: On December 23, 2022, Deputies from the Talbot County Sheriff's Office arrested Katrina Marie Dejullis, 34 of Fruitland, MD. On December 7, 2022, the Talbot County Circuit Court issued an arrest warrant charging Dejullis with failing to appear for a scheduled court hearing on the original charge of driving under the influence of drugs. Dejullis was transported to the Talbot County Central Booking facility for processing and was ordered held pending further action by the Circuit Court.

Handgun / CDS Arrest: On December 26, 2022, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Ocean Gateway near Proabasco Landing Road for moving violations. Deputies developed probable cause to conduct a search of the vehicle, locating a handgun and controlled substances in the possession of a passenger in the vehicle. The passenger was identified as Michael Anthony Williams Jr., 40 of Cecil County, MD. Williams was placed under arrest and charged with possession of a handgun and possession of marijuana. Williams was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Williams was held pending further action by the court. Warrant Arrest: On December 27, 2022, Deputies from the Talbot County Sheriff's Office arrested Lamont Charles Ross, 30 of Front Royal, VA. On December 5, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Ross with violation of probation. Over the last several years, Ross has been involved in thirty-two incidents involving police with twelve on site arrests and nine warrants being served. Ross was transported to the Talbot County Central Booking facility for processing and was ordered held without bond pending further action by the Circuit Court.

Warrant Arrest: On December 29, 2022, Deputies from the Talbot County Sheriff's Office arrested Kayla Marie Greenway, 25 of Federalsburg, MD. On October 21, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Greenway with failing to appear for a scheduled court hearing on the original charge of possession with the intent to distribute narcotics. Greenway was transported to the Talbot County Central Booking facility for processing and was ordered held without bond pending further action by the Circuit Court.

Warrant Arrest: On January 1, 2023, Deputies from the Talbot County Sheriff's Office arrested Michael Perry Cooper, 35 of McDaniel, MD. On November 9, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Cooper with failing to appear for a scheduled court hearing for child support. Cooper was transported to the Talbot County Central Booking facility for processing and was held pending further action by the Circuit Court.

Warrant Arrest: On January 1, 2023, Deputies from the Talbot County Sheriff's Office arrested Jake Albert Fluharty, 41 of Tilghman, MD. On November 16, 2022, the District Court for Talbot County issued an arrest warrant charging Fluharty with failing to appear for a scheduled hearing on the original charge of abandoning a vessel. Fluharty was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Fluharty was held pending further action by the court.

Handgun / CDS Arrest: On January 1, 2023, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Ocean Gateway near Dutchman's Lane for a moving violation. Deputies developed probable cause to search the vehicle, locating a stolen handgun and a controlled substance on a passenger in the vehicle, identified as Cornell Corey Contee, 32 of Centreville, MD. Contee was placed under arrest and charged with possession of a handgun, possession of stolen property and possession of a controlled substance. Contee was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Contee was ordered held pending further action by the court. Warrant Arrest: On January 2, 2023, Deputies from the Talbot County Sheriff's Office arrested Tyron Keenan Adams, 31 of Cambridge, MD. On May 3, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Adams with failing to appear for a scheduled hearing for child support. Adams was transported to the Talbot County Central Booking facility for processing and was ordered held pending his appearance before the Circuit Court Judge.

Warrant Arrest: On January 3, 2023, Deputies from the Talbot County Sheriff's Office arrested Nicholas James Fisher, 24 of Preston, MD. On October 21, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Fisher with failing to appear for a scheduled court hearing on the original charge of possession of a controlled substance. Fisher has been involved in thirty-four incidents involving police, been arrested fifteen times and served eleven arrest warrants, all prior to turning twentyfive years old. Fisher was transported to the Talbot County Central Booking facility for processing and was ordered held without bond pending an appearance before the Circuit Court Judge.

CDS Arrest: On January 5, 2023 at approximately 11:50 pm, Deputies from the Talbot County Sheriff's Office attempted to stop a motor vehicle on the Easton Bypass near Port Street for a moving violation. Initially, the vehicle failed to stop as required and turned onto several back streets before coming to a stop on Pleasant Alley. The driver of the vehicle was identified as James Sang Nguyen, 24 of Cambridge, MD and probable cause was developed to search the vehicle. Deputies located ammunition in the vehicle and a large quantity of cocaine a short distance from the vehicle, which was discarded during the pursuit. Nguyen was placed under arrest and charged with possession of a controlled substance with the intent to distribute, possession of a controlled substance, illegal possession of ammunition and fleeing and eluding a uniformed police officer. Nguyen was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Nguyen was ordered held pending further action by the court.
