## **PRESS RELEASES**

Warrant Arrest: On January 10, 2023, Deputies from the Talbot County Sheriff's Office arrested Quantez D'Lane Harris, 26 of Cambridge, MD. On December 13, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Harris with violation of pretrial release conditions on the original charge of handgun in vehicle. Harris was transported to the Talbot County Central Booking facility for processing and was ordered held pending a hearing with the Circuit Court Judge.

Warrant Arrest: On January 10, 2023, Deputies from the Talbot County Sheriff's Office arrested Mason Scott Kelly, 23 of Easton, MD. On January 9, 2023, the Circuit Court for Talbot County issued an arrest warrant charging Kelly with violation of probation on the original conviction of assault and theft. At the age of 23, Kelly has been involved in twenty-five incidents with the police in Talbot County, being arrested eighteen times and served twelve warrants. Kelly was transported to the Talbot County Central Booking facility for processing and was ordered held pending a hearing with the Circuit Court Judge.

Peace Order Arrest: On January 11, 2023, Deputies from the Talbot County Sheriff's Office served a criminal summons on Colby Jacob Palmer, 24 of Easton, MD. On January 10, 2023, Palmer responded to a residence on Kingston Road where a court issued peace order prohibits him from visiting. Palmer was charged on a criminal summons with failure to comply with a peace order and Trespassing. Palmer was released upon his signature and promise to appear for trial. Assault/DUI Arrest: On January 12, 2023, Deputies from the Talbot County Sheriff's Office were responding to the 9000 block of Unionville Road for a reported domestic assault. While responding, Deputies observed the suspect, Juan Antonio Morales-Cifuentes, 37 of Easton, MD, leaving the residence in a motor vehicle. Deputies determined Morales-Cifuentes was operating the motor vehicle under the influence of alcohol. Deputies made contact with the victim and observed injuries consistent with a domestic assault. Morales-Cifuentes was arrested and charged with assault and driving under the influence of alcohol. Morales-Cifuentes was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Morales-Cifuentes was ordered held pending further action by the court.

Assault Arrest: On January 9, 2023, a Talbot County Sheriff's Office, School Resource Officer arrested Drake Skylar Marshall, 18, of Cordova, MD for assaulting another student. Marshall was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Marshall was released on his personal recognizance.
