# PRESS RELEASES

**Warrant Arrest:** On January 10, 2023, Deputies from the Talbot County Sheriff's Office arrested Tashyra Nicole Walker, 34 of Easton, MD. On December 30, 2022, the District Court for Talbot County issued an arrest warrant charging Kelly with failure to appear on the original conviction of operating a motor vehicle with a suspended driver's license. Walker was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Walker was held pending further action by the court.

**Warrant Arrest:** On January 10, 2023, Deputies from the Talbot County Sheriff's Office arrested J'Sean Jermane Duncan, 25 of Easton, Maryland. On January 18, 2023, the District Court for Talbot County issued an arrest warrant charging Harris with failure to appear for court on the original charge of driving on a suspended driver's license. Duncan was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Duncan was held pending further action by the court.

**Warrant Arrest:** On January 20, 2023, Deputies from the Talbot County Sheriff's Office arrested Thomas Hooks Jr., 40 of Gaithersburg, MD. On June 15, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Hooks with failing to appear for a scheduled court hearing for child support. Hooks was transported to the Talbot County Central Booking facility for processing and was ordered held pending a hearing with the Circuit Court Judge.

**Warrant Arrest:** On January 20, 2023, Deputies from the Talbot County Sheriff's Office arrested Alejandro Deiandre Tadeo, 27 of St. Michaels, MD. On January 19, 2023, the Circuit Court for Talbot County issued an arrest warrant charging Tadeo with violation of probation on the original conviction of rape, sex offense and assault. Tadeo was transported to the Talbot County Central Booking facility for processing and was ordered held pending a hearing with the Circuit Court Judge.

**CDS / Handgun Arrest:** On January 21, 2023, at approximately 2:50 am, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Ocean Gateway near Wise Lane for moving violations. Deputies identified the driver as Draquan Tremarr Young, 27 of Cambridge, MD and a passenger as Michael Garrick Batson Jr, 34 of Cambridge, MD. Deputies developed probable cause to search the vehicle, locating a loaded handgun, marijuana and ecstasy tablets. Young attempted to flee on foot but was apprehended a short distance from the vehicle. Young was placed under arrest and charged with unlawful possession and transport of a handgun by a prohibited person, possession with the intent to distribute a controlled substance, resisting arrest and driving under the influence of alcohol. Young was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Young was held pending further action by the court. Batson was released without charges.

**CDS Arrest:** On January 23, 2023, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Ocean Gateway near Dutchman's Lane for an equipment violation. Deputies identified the driver as Aaron Simmons McCarthy, 22 of Cambridge, MD. Deputies developed probable cause to search the vehicle and located 363 grams of marijuana. McCarthy was issued a criminal citation for possessing criminal amounts of marijuana and released from the scene.

**Warrant Arrest:** On January 24, 2023, Deputies from the Talbot County Sheriff's Office arrested Seth William Hembree, 21 of Baltimore, MD. On December 9, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Hembree with violation of probation on the original conviction of child porn, solicit subject. Hembree was transported to the Talbot County Central Booking facility for processing and was ordered held pending a hearing with the Circuit Court Judge.

**Warrant Arrest:** On January 26, 2023, Deputies from the Talbot County Sheriff's Office arrested Lacey Marie Gregory, 28 of Ingleside, MD. On January 11, 2023, the District Court for Worcester County issued an arrest warrant charging Gregory with failing to appear for a scheduled hearing on the original charge of assault. Gregory was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Gregory was held pending further action by the court.

**Violation of Protective Order:** On January 26, 2023, Deputies from the Talbot County Sheriff's Office responded to the 23000 block of Mallard Point Road for a reported violation of a protective order. Deputies determined Raymond Joseph Weiss, 35 of McDaniel, MD, the respondent of an active protective order, violated the conditions of the protective order. Weiss was placed under arrest and transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Weiss was released on his personal recognizance.
