PRESS RELEASES

Domestic Assault Arrest: On January 27, 2023, Deputies from the Talbot County Sheriff's Office arrested Joshua John Fluharty, 31, of Tilghman, MD. Deputies responded to the 5000 block Black Walnut Point Road for a domestic assault in progress. Deputies made contact with Fluharty's wife who advised she was assaulted by Fluharty. Deputies observed injuries to the wife consistent with an assault and placed Fluharty under arrest. Fluharty was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Fluharty was ordered held without bond.

Warrant Arrest: On January 28, 2023, Deputies from the Talbot County Sheriff's Office arrested Eva Marie Ramsey, 38 of Easton, MD. On December 13, 2022, the District Court for Caroline County issued an arrest warrant charging Ramsey with failing to appear on the original charge of theft. Ramsey was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Ramsey was held pending further action by the court.

Assault/Sex Offense Arrest: On January 28, 2023, Deputies from the Talbot County Sheriff's Office served Michael Lynn Randolph, 69 of Cordova, MD with a criminal summons. Charges placed against Randolph were assault, sex offense, harassment and solicit prostitution. The charges were the result of a complaint from a postal carrier outside a residence in the 9800 block of Councill Road, Cordova, MD. The victim advised Deputies that Randolph touched her thigh and buttocks, while asking how much money to remove her pants. Randolph was issued a criminal summons and released on his signature.

Warrant Arrest: On January 29, 2023, Deputies from the Talbot County Sheriff's Office arrested James Pounds, 36 of Denton, MD. On March 14, 2022, the District Court for Caroline County issued an arrest warrant charging Pounds with theft and bad checks. Pounds was transported to the Talbot County Central Booking facility for processing and was released after posting a \$7,500 unsecured personal bond.

Peace Order Arrest: On January 29, 2023, Deputies from the Talbot County Sheriff's Office served a criminal summons on Javion Malik Willis, 19 of Trappe, MD. On January 25, 2023 and January 26, 2021, Willis harassed the petitioner of the peace order in which he is prohibited to do so. Willis was charged on a criminal summons with failure to comply with a peace order and was released upon his signature and promise to appear for trial.

Warrant Arrest: On January 31, 2023, Deputies from the Talbot County Sheriff's Office arrested Michael Allen Lednum, 37 of Denton, MD. An arrest warrant was issued by the Caroline County District Court for theft and unlawful taking of a motor vehicle from an incident that occurred on November 30, 2022. Lednum was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Lednum was ordered held without bond at the Talbot County Detention Center.

Assault Arrest: On February 1, 2023 at approximately 10:00 pm, Deputies from the Talbot County Sheriff's Office responded to the 9600 block of Tilghman Island Rd, McDaniel, MD in reference to an assault. Deputies learned Miles Jacob Porter, 35 of McDaniel, MD assaulted his girlfriend causing minor injuries. Porter was placed under arrest and charged with two counts of assault and reckless endangerment. Porter was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Porter was ordered held at the Talbot County Detention Center pending further action by the courts.
