PRESS RELEASES

Drug Arrest: On February 18, 2023, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Black Dog Alley near Kings Meadow Place, Easton, MD. Deputies identified the operator as Joe Robert Chambers 3rd, 37 of Laurel, DE, and with the assistance of a Talbot County Sheriff's Office (K-9) unit, developed probable cause to search the vehicle. Deputies located controlled substances in the vehicle. Chambers was arrested and charged with possession with intent to distribute a controlled substance, possession of a controlled substance and possession of paraphernalia. Chambers was also issued a traffic citation for driving a motor vehicle with a revoked license. Chambers was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Chambers was held pending further action by the courts.

Drug Arrest: On February 20, 2023, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Matthewstown Road and Councill Road for a moving violation. Deputies identified the driver as Jeffery Norman Wiseman, 48 of Federalsburg, MD and developed probable cause to search the vehicle. Deputies located controlled substances and paraphernalia. Wiseman was placed under arrest and charged with possession of a controlled substance and possession of paraphernalia. Wiseman was issued five (5) criminal citations and released from the scene upon his signature.

Warrant Arrest: On February 23, 2023, Deputies from the Talbot County Sheriff's Office arrested Charles Melvin Ernest Potter, 56 of Easton, MD. On February 17, 2023, the Circuit Court for Talbot County issued an arrest warrant charging Potter with failure to appear for a scheduled court hearing on the original charge of theft. Potter was transported to the Talbot County Central Booking facility for processing and was ordered held pending a hearing with the Circuit Court Judge.

Warrant Arrest: On February 24, 2023, Deputies from the Talbot County Sheriff's Office arrested Michael Dale Brown, 51 of Chestertown, MD. On February 17, 2023, the Circuit Court for Talbot County issued an arrest warrant charging Brown with violation of probation on the original charge of the distribution of narcotics. Brown was transported to the Talbot County Central Booking facility for processing and was ordered held pending a hearing with the Circuit Court Judge.

Assault Arrest: On February 20, 2023, Deputies from the Talbot County Sheriff's Office arrested Herman Demetrich Dwight, 42 of Trappe, MD for assault. The victim, whom resides with Dwight, reported to patrolling Deputies that on February 19, 2023 they were struck in the face after a verbal altercation. The deputies observed injuries consistent with an assault, and placed Dwight under arrest for domestic assault. Dwight was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Dwight was released on his personal recognizance.
