PRESS RELEASES

Warrant Arrest: On February 28, 2023, Deputies from the Talbot County Sheriff's Office arrested Jessica Farmer, 33 of Middle River, MD. On February 07, 2023, the Circuit Court for Talbot County issued an arrest warrant charging Farmer with failing to appear for a child support court hearing. Farmer was transported to the Talbot County Central Booking facility for processing and was ordered held pending a hearing with the Circuit Court Judge.

CDS arrest: On March 1, 2023, Deputies from the Talbot County Sheriff's Office attempted to stop a motor vehicle on Ocean Gateway near Matthewstown Road for an equipment violation. Upon activating emergency equipment, the suspect vehicle fled east bound on Ocean Gateway stopping near Tarbutton Mill Road. During the vehicle pursuit, deputies observed the driver, identified as Kyle Jeffery Wharton, 29 of Snow Hill, MD, throw objects from the vehicle. Troopers from the Maryland State Police assisted and were able to locate items thrown from the vehicle, identified as controlled substances. Deputies conducted a probable cause search of the vehicle and located additional controlled substances and paraphernalia. Wharton was placed under arrest and charged with possession with the intent to distribute controlled substances, possession of controlled substances, possession of paraphernalia and several traffic citations, including fleeing and eluding police. Wharton was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Wharton was ordered held pending further action by the court.

Warrant Arrest: On March 9, 2023, Deputies from the Talbot County Sheriff's Office arrested Lonnie Robert Joyner, 36 of Bozman, MD. On July 19, 2022, the Circuit Court for Talbot County, issued six arrest warrants, charging Joyner with six separate counts of failure to appear on the original charges of burglary, possession to distribute controlled substances and possession of controlled substances. On August 3, 2022, the Circuit Court for Talbot County issued two additional arrest warrants charging Joyner with failure to appear on the original charges of CDS. Joyner was transported to the Talbot County Central Booking facility for processing and was ordered held pending further action by the Circuit Court.

DWI/CDS: On March 10, 2023 at approximately 1:00 am, Deputies from the Talbot County Sheriff's Office responded to the 30000 block of Dover Road for a suspicious vehicle. Deputies located a vehicle stopped in the roadway and identified the driver as Margaret Anne Schamburg, 23 of Laurel, DE. Deputies developed probable cause to search the vehicle and located controlled substances. Schamburg was placed under arrest and charged with possession of a controlled substance and driving under the influence of alcohol and drugs. Schamburg was released on her signature, charged by criminal and traffic citations.

Warrant Arrest: On March 10, 2023, Deputies from the Talbot County Sheriff's Office arrested Daemonitae Jamar Bailey, 24 of Easton, MD. On March 9, 2023, the District Court of Talbot County issued an arrest warrant charging Bailey with assault and false imprisonment. Bailey was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Bailey was ordered held without bond.

CDS/Warrant Arrest: On March 10, 2023, at approximately 11:45 pm, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Ocean Gateway near Manadier Road for a moving violation. Deputies developed probable cause to search the vehicle and located a controlled substance on a passenger identified as Brooke Noel Bradley, 31 of McDaniel, MD. Deputies ran a records check on another passenger identified as Kurt Edward Miles, 50 of Pennsylvania, locating arrest warrants through the Maryland Natural Resources Police. Miles was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Miles was held pending further action by the court. Bradley was released upon her signature on a criminal citation.

Warrant Arrest: On March 11, 2023 at approximately 2:20 am, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Ocean Gateway near Manadier Road for a moving violation. Deputies identified the driver as Tshawn Akendra Taylor, 30 of Denton, MD. A records check revealed an arrest warrant charging Taylor with failure to appear at a scheduled court hearing. Taylor was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Taylor was held pending further action by the courts.

CDS/ Handgun Arrest: On March 11, 2023, Deputies from the Talbot County Sheriffs' Office stopped a motor vehicle on Marlan Drive near Old Trappe Road for an equipment violation. Deputies identified the driver as Samantha Marie Jones, 24 of Tilghman, MD and a front seat passenger as Javion Malik Willis, 19 of Trappe, MD. Deputies developed probable cause to search the vehicle and located marijuana and a loaded handgun. Willis was placed under arrest and charged with several handgun violations. Willis was transported to the Talbot County Central Booking facility for processing and his initial appearance before a District Court Commissioner. Willis was ordered held pending further action by the courts.

Warrant Arrest: On March 13, 2023, Deputies from the Talbot County Sheriff's Office arrested Tembra Jhadon Jones, 33 of Cambridge, MD. On March 10, 2023, the Circuit Court for Talbot County issued an arrest warrant charging Jones with failure to appear for a scheduled court hearing on the original charge of traffic offenses. Jones was transported to the Talbot County Central Booking facility for processing and was ordered held pending a hearing with the Circuit Court Judge. Maryland State Police assisted in the arrest of Jones.

Warrant Arrest: On March 13, 2023, Deputies from the Talbot County Sheriff's Office arrested Joseph Denning Ogletree, 46 of Easton, MD. On February 22, 2023, the District Court for Queen Anne's County issued an arrest warrant charging Harris with failing to appear in court on the original charge of driving without a license. Ogletree was transported to the Talbot County Central Booking facility for processing and was released on his personal recognizance.

CDS Arrest: On March 14, 2023, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Ocean Gateway near Hiners Lane for an equipment violation. Deputies identified the driver as Marshall Todd Thompson, 32 of Easton, MD and developed probable cause to search the vehicle. Deputies located controlled substances and placed Thompson under arrest. Thompson was charged on criminal citations for possession of a controlled substance and paraphernalia. Thompson was released on his signature.

Warrant Arrest: On March 14, 2023, Deputies from the Talbot County Sheriff's Office arrested Lakeevis D. Harrion, 23 of Easton, MD. On March 13, 2023, the Circuit Court for Talbot County issued an arrest warrant charging Harrion with violation of probation on the original charge of child pornography. Harrion was transported to the Talbot County Central Booking facility for processing and was ordered held without bond pending a hearing with the Circuit Court Judge.

Indecent Exposure Arrest: On March 15, 2023, Deputies from the Talbot County Sheriff's Office were dispatched to the 26000 block of Tunis Mills Road for a suspicious person knocking on doors and exposing himself. Deputies located and identified Antonio Lee Smith, 22 of St. Michaels, MD. Smith was placed under arrest and charged with indecent exposure. Smith was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Smith was held pending further action by the courts.

Warrant Arrest: On March 16, 2023, Deputies from the Talbot County Sheriff's Office arrested Daniel Joseph Leaman, 40 of Trappe, MD. On March 13, 2023, the District Court for Talbot County issued an arrest warrant charging Harris with escape. Leaman was transported to the Talbot County Central Booking facility for processing and was ordered held pending further action by the courts.

Warrant Arrest: On March 17, 2023, Deputies from the Talbot County Sheriff's Office arrested Floyd Archie Law, 51 of Cambridge, MD. On July 22, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Law with failing to appear. Law was transported to the Talbot County Central Booking facility for processing and was ordered held pending a hearing with the Circuit Court Judge.

Threat of Arson Arrest: On March 17, 2023, Deputies from the Talbot County Sheriff's Office responded to the 4500 block of Windy Hill Road for a verbal domestic. Deputies conducted an investigation and determined James Remington Leonard, 43, of Trappe, MD threatened to burn their residence. Leonard was placed under arrest and charged with threat of arson. Leonard was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Leonard was held pending further action by the courts.

Warrant Arrest: On March 20, 2023, Deputies from the Talbot County Sheriff's Office arrested Lewis Allen Todd, 29 of Dover, DE. On April 25, 2022, the District Court for Talbot County issued an arrest warrant charging Todd with violation of probation on the original charge of possession of a controlled substance. Todd was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Todd was held pending further action by the courts.
