# PRESS RELEASES

**Warrant Arrest:** On April 3, 2023, Deputies from the Talbot County Sheriff's Office arrested Mackenzie Allison Elliott, 30 of Cambridge, MD. On July 6, 2022 the Talbot County District Court issued an arrest warrant charging Elliott with failing to appear for a scheduled court date for a violation of probation hearing. Elliott was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Elliott was ordered held pending further action by the court.

**Warrant Arrest:** On April 4, 2023, Deputies from the Talbot County Sheriff's Office arrested Kyle Matthew Gibbons, 33, of Upper Marlboro, MD. On May 19, 2021, the Queen Anne's District Court issued an arrest warrant charging Gibbons with failing to appear for a scheduled court hearing on the original charge of driving while intoxicated and driving on a suspended out of state license. Gibbons was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Gibbons was held pending further action by the court.

**CDS/Trespassing Arrest:** On April 05, 2023, Deputies from the Talbot County Sheriff's Office observed a vehicle parked at the Trappe Veterans Park during hours the park is closed. Deputies identified the driver as Savieon Meyers, 18 of Easton, MD, and developed probable cause to search the vehicle. Deputies located marijuana and paraphernalia in an amount that indicated the intent to distribute. Meyers was issued criminal citations and was released from the scene on his signature.

**Warrant Arrest:** On April 6, 2023, Deputies from the Talbot County Sheriff's Office arrested Eric Drew Flynn, 39, of Federalsburg, MD. On March 4, 2022, the Circuit Court for Talbot County issued an arrest warrant charging Flynn with violation of probation on the original charge of theft. Flynn was transported to the Talbot County Central Booking facility for processing and was ordered held pending a hearing with the Circuit Court Judge.

Handgun/CDS Arrest: On April 7, 2023, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Ocean Gateway near Schwaninger Road for a moving violation. Deputies identified the occupants of the vehicle as Eugene William Rucker, 32 and Deandre Kato Mitchell, 25 both of Seaford, Delaware. Deputies developed probable cause to search the vehicle and located a handgun and marijuana. Rucker was placed under arrest and charged with possession of a handgun in a vehicle. Rucker was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Rucker was ordered held pending further action by the court.

Warrant Arrest: On April 8, 2023, Deputies from the Talbot County Sheriff's Office arrested Christopher Lamont Murray, 39 of Cordova, MD. On October 12, 2022, the Caroline County District Court issued an arrest warrant for Murray charging him with theft. Murray was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Murray was held pending further court action.

Warrant Arrest: On April 9, 2023, Deputies from the Talbot County Sheriff's Office arrested Brooke L Siggers, 32 of Elkridge, MD. An arrest warrant was issued by the Anne Arundel County District Court charging Siggers with assault. Siggers was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Siggers was held pending further action by the court.

Warrant Arrest: On April 11, 2023, Deputies from the Talbot County Sheriff's Office arrested Sammy L Young, 60 of Easton, Maryland. An arrest warrant was issued by the Talbot County Circuit Court charging Young with violation of probation. Young was transported to the Talbot County Central Booking facility for processing and was held at the Talbot County Detention Center without bond, pending a hearing with the Talbot County Circuit Court Judge.
