## **PRESS RELEASES**

Warrant Arrest: On May 3, 2023, Deputies from the Talbot County Sheriff's Office arrested Torrell Emmanuel Chester, 42 of Cambridge, MD. On April 5, 2022, the Talbot County Circuit Court issued an arrest warrant charging Chester with failure to appear at a scheduled court hearing. Chester was transported to the Talbot County Central Booking facility for processing and was ordered held pending an appearance before a Circuit Court Judge.

Warrant Arrest: On May 6, 2023 Deputies from the Talbot County Sheriff's Office arrested John James Seward, 51 of Deal Island, Maryland. On February 9, 2022 the Talbot County Circuit Court issued an arrest warrant charging Seward with failing to appear for a child support hearing. Seward was transported to the Talbot County Central Booking facility for processing and was ordered held on a \$2000.00 cash bond.

CDS Arrest: On May 8, 2023, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Glenwood Avenue near the Easton Bypass for a moving violation. Deputies identified the driver as Tony Edward Seth Jr., 43 of Easton, MD and developed probable cause to search the vehicle. Deputies located cocaine and marijuana. While in Deputies custody, Seth advised he ingested cocaine prior to the traffic stop and appeared to be showing signs of an overdose. Seth was evaluated and transported to the University of Maryland Medical Shore Center. Seth was released from Deputies custody and issued a criminal citation for possession of controlled substances.

Warrant Arrest: On May 8, 2023, Deputies from the Talbot County Sheriff's Office arrested Dregor Allen Thomas, 21 of Trappe, MD. On March 3, 2023, the Talbot County Court Commissioner issued an arrest warrant charging Thomas with theft, possession of Firearm, regulated firearm-unlawful sale/transfer. Thomas was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Thomas was held pending further action by the court.

Warrant Arrest: On May 8, 2023, Deputies of the Talbot County Sheriff's Office arrested Jeremiah Isaiah Carter, 18, of Trappe, MD. On May 4, 2023, the District Court of Wicomico County issued an arrest warrant charging Carter with firearms violations. Carter was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Carter was ordered held pending further action by the court.

CDS Arrest: On May 9, 2023, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Black Dog Alley near Kingston Road for a moving violation. Deputies identified the driver as Sean Demetreus Mellerson, 28 of Upper Marlboro, MD. Deputies developed probable cause to search the vehicle and located a large amount of marijuana and paraphernalia indicating an intent to distribute. Mellerson was charged with possession of a controlled substance with the intent to distribute, possession of a controlled substance and paraphernalia on a criminal citation and was released from the scene as required by law.
