# PRESS RELEASES

**Assault Arrest:** On June 17, 2023, Deputies from the Talbot County Sheriff's Office responded to the 11000 block of Kitty's Corner Road in reference to a domestic assault. Deputies made contact with a female victim who advised her live in boyfriend, Matthew Ronald Coenen, 43 of Cordova, MD had thrown her to the ground and assaulted her while she was on the floor. Deputies observed injuries consistent with an assault and placed Coenen under arrest and charged him with assault. Coenen was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Coenen was held pending further action by the court.

**CDS Arrest:** On June 22, 2023, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Dutchman's Lane near Seth Drive for a moving violation. Deputies identified the driver as, Matthew Caleb Gentry, 42 of Easton, MD and developed probable cause to search the vehicle. Deputies located a controlled substance and paraphernalia in the vehicle. Gentry was issued a criminal citation and released from the scene on his signature.

**Warrant Arrest:** On June 25, 2023, Deputies from the Talbot County Sheriff's Office arrested Ismael Rodimiro Perez-Aldana, 31 of Easton, MD. An arrest warrant was issued by the Talbot County District Court for failure to appear at a scheduled court hearing on the original charge of driving under the influence of alcohol. Perez was taken to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner.

**Warrant Arrest:** On June 25, 2023, Deputies from the Talbot County Sheriff's Office arrested Victor Ellis Battle, 42 of Easton, MD. An arrest warrant was issued by the Saint Mary's County District Court for failure to appear at a scheduled court hearing on the original charge of possessing a controlled substance. Battle was taken to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Battle was released on his own recognizance.

DUI/Fleeing and Eluding Arrest: On June 25, 2023, Deputies from the Talbot County Sheriff's Office and Officers of the Saint Michaels Police Department were notified of a vehicle operating in a reckless manner. Officers from the St. Michaels Police Department located the vehicle on the shoulder of the roadway and attempted to make contact. The driver identified as, Ismael Rodimiro Perez-Aldana, 31, of Easton, MD, sped off. Deputies observed the vehicle and attempted to stop the vehicle. Perez-Aldana continued to elude Deputies speeding and driving recklessly. Perez-Aldana lost control of his vehicle and crashed into the wooded area on Solitude Road. Perez-Aldana was transported to Easton Memorial Hospital for evaluation and was charged with driving under the influence of alcohol, driving on a suspended license, fleeing and eluding a uniformed police officer and numerous moving violations. Perez-Aldana was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Perez-Aldana was incarcerated on an open arrest warrant for a previous driving under the influence of alcohol, where he failed to appear for his scheduled court hearing.

Warrant Arrest: On June 26, 2023, Deputies from the Talbot County Sheriff's Office arrested Leon Allan Rasin, 28 of Easton, MD. On February 7, 2023, the Circuit Court for Talbot County issued an arrest warrant charging Rasin with violating his probation on the original charge of assault. Rasin was transported to the Talbot County Central Booking facility for processing and will be held pending a hearing with the Judge of the Circuit Court.

Warrant Arrest: On June 27, 2023, Deputies from the Talbot County Sheriff's Office arrested Miles Jacob Porter, 35 of Tilghman Island, MD. On June 7, 2023, an arrest warrant was issued by the Talbot County Circuit Court charging Porter with failing to appear at a scheduled court hearing on the original charge of assault. Porter was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Porter was released on a \$20,000.00 unsecured bond.

Warrant Arrest: On June 28, 2023, Deputies from the Talbot County Sheriff's Office arrested Michael Lynn Goode, 38 of Cambridge, MD. On March 20, 2023, the Talbot County District Court issued an arrest warrant charging Goode with failing to appear for a scheduled court hearing on the original charge of driving without a license. Goode was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Goode was held pending further action by the court.

Warrant Arrest: On June 29, 2023, Deputies from the Talbot County Sheriff's Office arrested Eric Leslie Werner, 62 of Tilghman Island, MD. An arrest warrant was issued by the Talbot County Circuit Court charging Werner with sexual abuse of a minor. Werner was already being held at the Talbot County Detention Center without bond for similar charges.

CDS Arrest: On June 29, 2023, Deputies from the Talbot County Sheriff's Office stopped a motor vehicle on Ocean Gateway near Landing Neck Road for an equipment violation. Deputies developed probable cause to search the vehicle and located controlled substances. A passenger, Cerron Donnell Gordon, 24 of Essex, MD was charged on a criminal citation for possession of a controlled substance. Gordon was released from the scene on his signature.

Warrant Arrest: On June 30, 2023, Deputies from the Talbot County Sheriff's Office arrested Steven Kevin Tarleton, 30 of McDaniel, MD. On April 18, 2023, the Talbot County District Court issued an arrest warrant charging Tarleton with failing to appear for a scheduled court hearing on the original charge of driving an uninsured vehicle. Tarleton was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Tarleton was held pending further action by the court.
