Criminal Investigation Division

Firearm Arrest: The Talbot County Sheriff's Office has arrested Dregor Allen Thomas, 20, of Trappe, Maryland for charges stemming from illegally purchasing a stolen firearm and being a minor in possession of a firearm. Thomas was charged with four counts of theft: \$100 to under \$1,500; four counts of theft less than \$100; four counts of possession of firearm/minor; four counts of regulated firearm: stolen/sell etc.; and one count of regulated firearm-unlawful sale/transfer.

The Criminal Investigations Division obtained an arrest warrant and it was served on May 8, 2023. Thomas was seen by a Talbot County District Court Commissioner and was held without bond. On May 9, 2023 Thomas had a bail review in Talbot County District Court where he was released on a \$30,000 unsecured personal bond. Thomas' case is pending further court proceedings.

Theft/Fraud Arrest: The Talbot County Sheriff's Office, Criminal Investigations Division has obtained criminal charges for a Talbot County woman related to an investigation for theft and check fraud. Nancy P. Guiseppe, 71, of Easton, Maryland has been charged with the below listed criminal charges:

- 1) 2 counts of Theft \$1,500 to under \$25,000
- 2) 31 counts of Theft \$100 to under \$1,500
- 3) 2 counts of Theft less than \$100
- 4) 1 count of Fraud \$1,500 to under \$25,000
- 5) 31 count of Fraud \$100 to under \$1,500
- 6) 68 counts of Forgery

In December of 2022, the Talbot County Sheriff's Office received a complaint regarding a caretaker who was forging checks in the victim's name and cashing them. The Criminal Investigations Division conducted an extensive investigation and filed for the above listed criminal charges against Guiseppe. She was served with a criminal summons on July 21, 2023. Guiseppe's case is pending further court proceedings.
