PRESS RELEASES

Assault Arrest: On October 14, 2023, Deputies from the Talbot County Sheriff's Office arrested William Daniel Sard, 41 of Trappe, MD for an assault which occurred in the 4200 block of Wrights Mill Rd, Trappe, MD. Investigation revealed Sard assaulted a 17 year old male by striking and choking him. Sard was charged with first and second degree assault and reckless endangerment. Sard was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Sard was ordered held without bond.

Warrant Arrest: On October 16, 2023, Deputies from the Talbot County Sheriff's Office arrested Michael Moses Ruark, 47 of Salisbury, MD. On March 29, 2022, the Talbot County Circuit Court issued an arrest warrant charging Ruark with failing to comply with the court sentence. Ruark was transported to the Talbot County Central Booking facility for processing and was held pending further action by the Circuit Court Judge.

Warrant Arrest: On October 17, 2023, Deputies from the Talbot County Sheriff's Office arrested Seth William Hembree, 22 of Easton, Maryland. On August 4, 2023, the District Court for Talbot County issued an arrest warrant charging Hembree with failing to abide by the mandatory reporting guidelines of a registered sex offender. The Circuit Court of Talbot County issued an arrest warrant charging Hembree with violation of probation stemming from the same incident. Hembree was transported to the Talbot County Central Booking facility for processing and was held without bond.

Warrant Arrest: On October 17, 2023, Deputies from the Talbot County Sheriff's Office arrested Berdadrian Jrae Pittman, 26 of Easton, Maryland. On October 11, 2023, the District Court of Talbot County issued an arrest warrant charging Pittman with assault, reckless endangerment and violation of a protection order. Pittman was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Pittman was held pending further action by the court.

Warrant Arrest: On October 18, 2023, Deputies from the Talbot County Sheriff's Office arrested Shawn Steven Allen, 48 of Cordova, MD. An arrest warrant was issued by the Queen Anne's County District Court Commissioner charging Allen with arson. Allen was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Allen was ordered held pending further action by the court.

Warrant Arrest: On October 18, 2023, Deputies from the Talbot County Sheriff's Office arrested Cornell Samuel Rookard III, 35 of St. Michaels, MD. An arrest warrant was issued by the Talbot County District Court charging Rookard with violating the sex offender registration requirements. Rookard was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Rookard was ordered held at the Talbot County Detention Center without bond.

Warrant Arrest: On October 20, 2023, Deputies from the Talbot County Sheriff's Office arrested Kevron Lamonte Chase, 34 of Easton, MD. On October 11, 2023, the Anne Arundel County District Court issued an arrest warrant charging Chase with violating the terms of his probation on the original charge of driving without a license. Chase was transported to the Talbot County Central Booking facility for processing and an initial appearance before a District Court Commissioner. Chase was held pending further action by the court.
